## Budget Updates

- President's Budget Request FY 2020 – proposed reductions in Section 105
- Continuing resolution provides funding through November 21, 2019.
- Additional CRs or full-year appropriation beyond 11/21/19?
- The House & Senate approved an appropriation that included funding for EPA
- Possibility - Conference Committee to finalize Appropriation for FY 2020 Interior and Environment Appropriations bills?



## FY 20 Budget

- FY20 Continuing Resolution (CR)
  - Short-term CR until November 21st (52 days)
  - Based on 2019 Enacted Budget
    - CR includes no rescission
    - This equals roughly 16.1% of the 2019 Enacted Budget
  - New Grant applications are being processed & partial awards completed by 12/31/2019

  - Include 3 essential elements in Annual Summary Report (EPA Strategic Plan Goal, EPA Strategic Plan Objective, Workplan commitments plus timeframe).
- Section 103 Performance Report date - **03/31/2020** PM 2.5
- Section 103 PM2.5 grant project period thru **3/31/2020**, new Section 103 PM2.5 grants to be awarded for April 1, 2020
- New PM2.5 grant applications due to be submitted in grants.gov by **February 1, 2020**
